



Good evening Mr. Mayor, City Council Members, and Belvidere Police Officers

I am indeed touched to be invited to speak to you all tonight by Chief Woody, all be it not in person due to COVID. It is a very different way for me to speak, but it is an unprecedented time in our history.

Currently, there are no specific statistics as to how the pandemic has impacted impaired driving habits. It is just too soon to tell. Law Enforcement in our area is reporting increases in speeding throughout the pandemic and an increase in drug and alcohol use. The only thing we know for sure from IDOT is that crashes and fatalities have always historically correlated with miles traveled and in 2020 crashes and fatalities significantly outpaced miles traveled. Everyone in traffic safety is shocked by this increase.

Sadly, our story started long before the pandemic, our 20-year-old son Christopher Krenzer was killed by an impaired driver on August 26th, 2010. He was hit by a 20-year-old young man who was already on probation for his first DUI. This young man bragged about how he fooled the police two weeks before killing Chris on a routine traffic stop when he was impaired. The night he killed Chris, he bragged to police that he was a better driver drunk than sober.

From the moment Chris was killed everything became a blur, our lives were rocked to our core, we were brought to our knees. The crash was all over the news, the defendant's face stared at us on TV, in the papers, and on the internet. We walked around for months, really

years...like zombies. Waking up each day to the realization of Chris was dead and never coming home ever again, haunted me. How was my husband and I going to survive the death of our youngest child? How was my oldest son going to deal with losing his brother? How were my parents going to cope and the rest of our family?

The pain was unbearable. I can only give you a small window into what the pain is like. It was like someone took a hammer to all your fingers and smashed them, only that pain was in your heart pulsing through your chest and body and you live like that for the rest of your life.

It is so senseless to lose your child all because of someone else's selfishness to drive impaired. We all know to have a plan in place, a designated driver, call a friend, taxi, or an Uber is the best option to get home safely. But sadly, we have many people who do not follow the law and view this behavior as acceptable. Out of our pain becomes purpose I am a Victim Advocate with the Alliance Against Intoxicated Motorists supporting victims of impaired driving crashes.

This is one of my favorite parts of my job, supporting our police officers. Thank you to the Belvidere Police Officers for every DUI arrest they make everyday year after year. We the public, the victims, and the families of these tragedies band together and continue to be a loud voice for our loved ones. We all know the police certainly take a lot of abuse from drivers while accessing impaired drivers. And officers are never going to know whose life they potentially saved by removing that impaired driver off the road. They certainly are not thanked enough for all they do.... but AAIM is here to thank you, I am here to thank you. I still have a child that drives these roads and I wish him to come home to us safe every day. It is my honor to thank Officer Matthew Korn with 18 DUI arrests, Officer Christopher Garcia with 11 DUI arrests, and Officer KC Brox with 11 DUI arrests.

I know all of these officers would be modest and say they are just doing their job. But it is more than that. These officers saved a family from getting the news we got, that summons to the hospital, the countless tears of grief cried by hundreds. Just because they did their job and removed the threat.

These officers are never going to get a thank you from families they have potentially saved because the families do not know what could have happened! The arrest of the impaired driver broke that chain of potential events. But I know what could have been and I am thanking you for your hard work. It is a simple word thank you but said with the sincerest meaning. You Officer's Korn, Officer Garcia, Officer Brox, and the entire Belvidere police department make a difference to so many. Thank you again.

RE: Request to approve Orthopedic surgery for Belvidere Police K-9 Shep

In October 2020, during a routine wellness check, Belvidere Police K-9 Shep presented with a limp in the hindlegs. Upon exam it was determined that K-9 Shep needed an orthopedic opinion.

Veterinary Specialty Center, Buffalo Grove, diagnosed K-9 Shep with a partial Cranial Cruciate Ligament tear and recommended surgery as the treatment option. The estimate for treatment was 4,600 - 5,100 dollars.

The Belvidere Police Department sent Officer Reese and K-9 Shep to UW Veterinary Clinic for a second opinion. UW Veterinary Clinic concurred with the initial diagnosis and estimated cost of treatment with a "working dog" discount of 20% at 2,800-3,280 dollars.

If surgery is approved K-9 Shep would have to undergo rehabilitation at Rehab-Companion Animal Specialty and Emergency Hospital with an estimated cost of 450 – 800 dollars.

Motion: The Belvidere Police Department is requesting authorization to have surgery and rehabilitation for K-9 Shep in accordance with the medical plan not to exceed \$4,080.00.

Please review the attached case summary reference the orthopedic exam conducted by the UW Veterinary Animal Hospital on December 29, 2020 to "Shep's" bilateral partial right cranial cruciate rupture of his knee.

UW Veterinary clinician, Jason Bleedom, DVM, MS, DACVS, suggests a tibial plateau leveling osteotomy (TPLO) surgical repair of the "Shep's" right knee. The procedures approximate cost is \$3,500.00 - \$4,100.00 with the working dog discount of 20% the approximate cost would be \$2,800.00 - \$3,280.00.

Diagnoses/presenting complaints

1. Bilateral partial cranial cruciate ruptures

Diagnostic tests/comments

Orthopedic exam

Grade 1 left hindlimb lameness, grade 2 right hindlimb lamness. Mild effusion in left stifle moderate effusion right stifle. Moderate pelvic limb muscle atrophy R>L. Thickening of the stifle bilaterally. Negative tibial thrust and cranial drawer bilaterally.. No meniscal click appreciated. Remainder of exam WNL.

Case Summary

Shep was diagnosed with suspect partial cranial cruciate ligament tears on today's visit. Shep's knees feel stable at this time, but the partial tears likely have led to inflammation, swelling, and discomfort of his joints, giving him an apparent limp. As we discussed today, the only way to know for sure would be to scope his stifles (knees) to evaluate the patency of his cruciate ligaments. Joint taps would also be recommended at that time due to his lyme exposure. We discussed that surgery may be helpful for Shep to improve his mobility and comfort. This procedure is not emergent, however Shep's partial tears may progress to complete tears making him acutely worse. At that time, surgery is recommended. Please see the following information for conservative management of Shep's partial tears.

History:

Shep is a 2 year old male german shepherd dog presenting to UW veterinary care for suspect right partial cranial cruciate ligament rupture. In october it was noted that Shep began to limp in his right hindlimb. He was seen be his primary veterinarian where he was postitive for lyme disease on 4dx, and a Quant C6 was submitted (206). He was started on a 30 day course of doxycycline. Shep's lameness remained approximately the same, and he was seen by a specialty hospital where he was diagnosed with a partial tear of his right cruciate. He was prescribed an anti-inflammatory (carprofen). Shep's lameness is described as intermittent with good and bad days at this time.

Physical examination upon presentation to UW Veterinary Care

Wt: 37 kgs, Body condition score: 4/9 (4 and 5 = ideal) T: not taken °F, P: 130 bpm, R: 24 rpm MM: pink, moist, CRT: not assessed Hydration: Adequate Attitude: nice, but muzzle for ortho exam

EYES, EARS, NOSE, MOUTH: Clear corneas & anterior chambers OU; No ocular or nasal discharge; ears are clean and free of debris

AU; very mild dental tartar with no masses or lesions; no cough elicited on tracheal palpation

CARDIOVASCULAR: No murmur or arrhythmia ausculted. Strong and synchronous femoral pulses. RESPIRATORY: Normal bronchovesicular sounds heard over all lung fields. No crackles or wheezes.

ABDOMINAL: No pain, organomegaly, or masses on abdominal palpation. LYMPH NODES: All peripheral lymph nodes are soft, small, and symmetrical.

SKIN: Full and clean haircoat; no ectoparasites noted.

MUSCULOSKELETAL: See orthopedic exam

NEURO: Appropriate mentation; palpebral and menace responses intact; no evidence of peripheral deficits.

Discharge instructions/comments

CONSERVATIVE MANAGEMENT

It is unlikely that Shep will receive much improvement with conservative management alone. While rest has been shown to be effective for dogs less than 15 kg, it is unlikely that Shep's knees will improve significantly with conservative management.

JOINT SPECIFIC DIET

Specific "joint protective" canine diet formulations are available for purchase through your veterinarian. It is our observation that dogs fed these diets have significantly less clinical signs from chronic arthritis than dogs on regular maintenance diets. These diets have a favorable ratio of omega-3 to omega-6 fatty acids which may decrease inflammation in the joints. Examples of such diets include Hills Science Diet J/D and Purina JM. If you decide to use one of these diets, gradually introduce Shep to this new food over 1-2 weeks by slowing adding the joint specific diet while decreasing the amount of normal food.

JOINT SUPPLEMENTS

Glucosamine and Chondroitin sulfate (i.e. "Cosequin") are normal constituents of articular cartilage that can be administered as dietary supplements (nutraceuticals). These supplements are thought to decrease the inflammatory mediators released within a joint in active osteoarthritis. Please discuss adding Cosequin or similar nutraceuticals to your Shep's diet with your local veterinarian.

NON-STEROIDAL ANTI-INFLAMMATORY DRUGS (NSAIDs)

You may give prescription NSAIDs to Shep to improve the level of comfort and allow wider range of motion of the affected joints. You have been prescribed carprofen (Rimadyl) at this time to trial for Shep's discomfort.

The surgical options for Shep at this time would be to evaluate his cruciate ligaments with a scope. Should they be completely ruptured, or Shep becomes more symtomatic, a TPLO procedure is recommended.

TIBIAL PLATEAU LEVELING OSTEOTOMY (TPLO)

In this surgical repair, a curved cut is made in the upper part of the tibia. The cut piece is then moved to change the normal anatomy of the top of the tibia, which is a forward-facing slant, to a flat surface. The bone piece is then held in place by a bone plate. The flat surface of the tibia then provides added stability to the stifle joint, slowing the arthritic progression. Estimated cost is \$3500-\$4100.

Feeding/exercise instructions

Feeding: maintaining a healthy weight may be the most important element in assuring the best possible quality of life. Body weight increases the load on all joints and causes more rapid progression of the degenerative changes, resulting in severe pain and inability to tolerate even non-strenuous physical activity. The goal for Shep is to have a slight "waist" when viewed from above, a "tummy tuck" when viewed from the side, just in front of the hips, and you should be able to easily feel the ribs without seeing them. To monitor Shep's weight, please have him weighed at your local veterinarian's office periodically to ensure objective control. Shep is an excellent body condition at this time.

Exercise: LOW IMPACT ACTIVITY. For now, Shep's exercise should be kept to a minimum with short leash walks. This will allow scar tissue to develop and stabilize his knee (stifle) joints. After 3 months of exercise restriction, a low-impact exercise regimen may help with preventing severe clinical signs associated with osteoarthritis. The most common high impact activities are running, jumping and rough playing with other dogs. These should be minimized. The single most efficient way to perform low impact exercise is swimming, although this is not always feasible. Regardless, daily leash walks are encouraged, but should be at a slow pace. The goal of physical activity is to maintain good muscle mass and prevent muscle atrophy while protecting the articular cartilage of the joints. You may also consider a customized physical therapy program. UW Veterinary Care offers that option through our animal physical therapist, Courtney Arnoldy. If that is your choice, we encourage you to call her for an appointment at 608-263-7600.

Dear Mayor:

As you know, we are working with Rock Valley College to redevelop the vacant Shopko Building into the Advanced Technology Center. Due to the significant increase in the initial scope of the project, RVC will need to increase the incoming domestic water service from a 2" connection to a 3" connection. The upsizing is due solely to the increase in the fixture count for things like eye wash stations, wash basins, etc. They do not anticipate a significant increase in water and sewer usage from what was experienced during the operation of the Shopko store..

RVC has included the installation of the 3" main in their construction costs and are simply asking that the City waive the connection fee cost differential between a 2" and 3" connection. The number provided by the Public Works Department is \$12,863 (\$6,270 for water and \$6,593 for sewer).

We appreciate consideration of this request. RVC has greatly expanded the scope of this project from the original RFP (50,000 square feet to 77,000 square feet) and is including far more programming than initially anticipated. They have also made provisions to add automotive programming to Belvidere in coming years. Thank you again for considering this request.

Re: Sanitary Sewer Backup – 1305 West 12th Street

We were notified of a sanitary sewer backup at 1305 West 12th Street and after finding the main line clear, we advised the property owners, Ken and Janice Anderson, that the backup was within their service line. The backup was contained in the basement with no damage resulting from the backup. Per section 114-348 of our Code, the City is responsible for repair and maintenance of a sanitary sewer lateral within the public right-of-way and the property owner is responsible for the remainder of the lateral outside of the right-of-way. Per our policy, the property owner must provide evidence that the repair is located in the right-of-way and not on private property.

The Anderson's hired Pearson Plumbing to complete the necessary work. Pearson's proposal included a worse case scenario of \$3,900 if a new service lateral was required from the house to the property line. Pearson first made a video of the service lateral from within the residence which was dark and inconclusive and Pearson was notified by our Water & Sewer Foreman that a better video was needed. Pearson then proceeded to excavate outside of the residence at the foundation and install a cleanout which allowed the service line to be jetted and televised. The picture then provided to the City clearly showed the broken lateral at a distance indicating the break to be in the public right-of-way. The Water & Sewer Department then made the appropriate repairs.

Pearson Plumbing's total bill for their work came to \$3,054.00, which included \$784.00 for jetting and televising the sewer lateral and \$2,270.00 for the excavation and installation of the sanitary sewer cleanout. The property owners are not happy that their bill is so large when the break was in the right-of-way and the responsibility of the city to repair.

Having reviewed this matter, I think that better communication between the contractor and city could have alleviated the installation of the cleanout on the outside of the residence in this instance. Therefore, I would recommend that the property owner be reimbursed \$2,270.00 for repair of the sanitary sewer lateral at 1305 West 12th Street. Owner to submit a paid statement from Pearson Plumbing prior to reimbursement.
