Foote



Belvidere pharmacist John Foote built a state-of-the-art, Prairie style home in 1913, but lived only four years to enjoy it.

RUNS IN THE FAMILY- John Crocker Foote was born in Hamilton, N.Y., in 1841. He moved to Belvidere in 1869 after taking over the Hamilton drug store of his father, John "J.J." Foote. Foote opened his Belvidere pharmacy, the J.C. Foote Drug Store, in 1870. It apparently was located in the Foote Building at 508 S, State St, for decades. Practicing with John was his second cousin, Daniel E. Foote, M.D. Daniel was one of Belvidere's first physicians, coming here in 1854.

If Walls Could Talk By: Kathy Sterbenc, Belvidere Daily Republican (Originally appeared in August 6, 1990 issue of BDR) John's father served as a New York state senator, supervisor of the Boone County Agricultural Society, and Belvidere's representative on the County Board of Supervisors. He retired to a farm near Belvidere. Meanwhile, John was elected in 1883 as one of our first city treasurers.

Success ran in the Foote family. J.J.'s grandfather, Isaac Foote, served on the Connecticut State Legislature. A judge, Isaac represented his area in the general convention during the writing of the U.S. Constitution.

John and his wife had three daughters, Helen, May and Florence. All of them survived him when he died early in the morning of July 12, 1917, at home.

First Presbyterian Church bought the house in 1928 for \$15,000 and used it for church functions. Countless couples were married in a chapel there; Boy Scouts roamed the halls, and toddlers played in the remodeled library and solarium. Women's groups held meetings and functions there, and the minister's office was upstairs. When missionaries stayed in town, they had bedrooms in the Foote house. Church printing was done in the basement. The church made the only exterior change, adding a door to the basement on the southeast corner of the house.

Ronald Semevolos bought the house in 1972 and began restoring damaged walls and woodwork. He sold the house in August 1988 to current owners Ed and Sherry Marx, who work non-stop to restore the house to its original glory.

PRAIRIE STYLE- The 20-room Foote house is a Prairie style home with post-1900 Colonial Revival details. The house, like 25 percent of Colonial Revival homes, is a two-story rectangular block with hipped roofs. The foundation of rough-cut, regular-course stone leads into fired-brick walls. What we call the front porch is actually the one-story "porte cochere," built to load and unload carriage passengers comfortably in all weather. It's supported by round, classical columns. The back porch is really a "portico," a roof supported by columns.

Paired, single-sash windows over the porte cochere light a stairway to the second floor. Many of the house's other windows are double-hung with "lights," or smaller panes, in the upper sash. Many windows also have granite sills.

Two full-height bay windows dominate the northeast side of the house, with bays in the large living room and two upstairs bedrooms. The low-hipped roof has wide, overhanging eaves accented with dentils, or notched trim. The front dormer has a flat roof and four windows in a row called a "ribbon." The other dormers have hipped roofs and three windows in a row, called "triplets." The original chimneys are corralled, meaning one or more courses of masonry protrude for the surface of the chimney. The fireplace in the living room is made of iridescent tile. The mantel's cornice (the multi-layered sides) have "reeded" pilasters running down the front and sides of the fireplace. The original andirons rest in front of the fireplace.

Foote used all of the modern methods available when building the house. Ed Marx said the house was one of the first to use conduit wiring, the method still used for electricity. Foote also was one of the first homebuilders to have hand-poured concrete walls.

He also showed genius in his generous use of another modern convenience—walk-in closets.

2021 Historic Property Maintenance Program



The Belvidere Historic Preservation Commission awards four property maintenance grants for exterior renovations. 405 West Hurlbut Avenue was awarded funds to assist in repainting the exterior of the home and commercial properties at 409 S. State Street, 410 S. State Street and 426 S. State Street were awarded funds for windows, doors, brick repair and paint. Unfortunately due to material shortages and rising costs of those materials available, many of the projects have been delayed.

The Historic Property Maintenance Program is funded by various fundraisers hosted by the Commission and Images of America book sales. Any property that is locally or nationally landmarked or located within a registered historic district is eligible to apply for the annual grant funds to assist in exterior renovations.



Lustron Houses

Have you ever wondered the history of the blue steel house on N. State Street? Well, that is a Lustron House and Belvidere has four of them. One even have the extremely rare Lustron garage too!

Constructed entirely of steel, the modest ranches were entrepreneur Carl Strandlunds answer to the severe housing shortage that plagued the country at the end of World War



II. But Strandlund's Lustron Company produced just 2,500 of these homes of the future, before declaring bankruptcy in 1950. A half century later, speculation about the events leading to the demise of the company remains. WGN will be airing a segment on Lustron Houses on April 2nd at 6:30pm. There will also be an in-depth article in the Boone County Journal this spring. Stay tuned!
