BELVIDERE POLICE CHIEF

Ms. Frank introduced police Chief Shane Woody. Chief Woody thanked the committee for having him. Chief Woody is the new police chief for the City of Belvidere. He gave a history of his career with the committee. He previously worked for the County and then moved to the City. He is most proud of his position as Field Training Officer and discussed this with the committee. He continued to discuss his career with the City of Belvidere. His last position prior to being appointed to Police Chief was Deputy Chief of Operations and explained this position to the committee. He has had many opportunities for learning and growth. Chief Woody stated that the Belvidere Police Department is on a good path with a solid direction and there will not be significant changes in operation and explained why. Chief Woody discussed community cooperation with crime in the City. The department will be implementing Tasers. Cathy Ward asked over his 20 years with the force what the biggest changes have been. Chief Woody responded that the laws have changed and the department's policies as well. Chief Woody is from Rockford/Loves Park. There are forty-three sworn officers in the department. Ms. Ward on behalf of the committee welcomed Chief Woody to attend any future committee meeting.

E-911 REPORT – PUBLIC SAFETY BUILDING

911 REPORT

Lt. Gay discussed and reviewed the 911 report. This perhaps may be his last meeting as Lt. Molloy will be stepping into the position. Lt. Gay discussed the fifteenth dispatcher hire with the committee and how this is saving in overtime costs. There were approximately 120 applicants from the new testing pool. Interviews have taken place and have made two selections for the sixteenth dispatcher and the retirement in the department as of May 1, 2018. Training will begin in March and April. He discussed the financials and the upcoming expenses for the NINJA project. Cathy Ward asked about the ifiber progress. Lt. Gay said there is no new progress to report on ifiber being

used as a voice carrier. There are more meetings that will be coming up. Mr. Terrinoni said the ifiber board is discussing its role in this matter. Unfortunately the root cause of this that one of the bidders that did not receive the contract for NextGen filed an objection with the Illinois Commerce Commission claiming that ifiber cannot contract with NextGen 911 to carry voice traffic. Mr. Carlisle asked about the I-90 fiber which is different from ifiber and Mr. Terrinoni explained this. Discussion was held on this project. There is not a completion date and Lt. Gay explained the importance of getting this completed. There was discussion on a backup plan for the project in the event ifiber is denied this arrangement with NextGen 911 by the Illinois Commerce Commission.

Lt. Gay said the public safety building is experiencing water issues and wanted the committee to be informed. He also discussed air conditioner units for the building. There is one unit that will be replaced soon. The replacement of two additional units was discussed. Cathy Ward asked if these replacements are budgeted and Lt. Gay responded. The water issues were discussed.

Sheriff Ernest was pleased to have Shane Woody as the new Chief and to continue to have the cooperation between the City and County and going to be a seamless transition.

Lt. Molloy in moving forward his door is always open and to feel free to reach out to him.

Sherry Branson discussed the water quality in the jail. Sheriff Ernest explained the water issues in the jail and public safety building. The water will be retested and an update will be provided next month. Sherry Branson expressed her concerns on the water quality. Sheriff Ernest feels there is no risk of the quality and more of a pipe issue.

The committee thanked Lt. Gay for his service to the committee and wished him well in his new position with the County.

<u>GIS</u>

GIS MAPS FLYOVER SCOPE OF WORK

Mr. Terrinoni said this is a County expense for the GIS flyover. This has passed through Roads and Capital Improvement Committee. Mr. Terrinoni just wanted to share this information and explained what consists of the flyover with the committee. He is hoping this will be done by the end of March the beginning of April.

LANDFILL

APPROVAL OF INVOICE: TRC

A motion was made by Cathy Ward to approve invoice #272367 in the amount of \$9,509.66 to TRC with a 50/50 split between the City and County. Motion seconded by Carl Larson. Motion passed (8-0).

Marsha Freeman asked about verbiage on the invoice for additional work. Mr. Terrinoni stated that the repair has been approved and budgeted and is related to the gas collection system. This work has not been completed.

ILLINOIS EPA/LANDFILL COMMUNICATION

Mr. Terrinoni referenced an e-mail from the IEPA pertaining to the solar project at the landfill. This is a positive response. The IEPA listed some requirements in moving forward with the project. Mr. Terrinoni is requesting the company to pay for the supplemental application requirements. Mr. Carlisle spoke to the committee regarding the letter that was submitted to the IEPA. Mr. Terrinoni said TerraNavigator will not want panels placed on the mound at the landfill only the flat areas. TerraNavigator will need to map the surface to determine the usage. Mr. Terrinoni discussed how the project will move forward. Mr. Carlisle discussed the IEPA giving permission on the flat surface of the landfill. He also discussed where the project is at and what remains to be done. Mr. Terrinoni said to move the project forward they would need a lease option. Then TerraNavigator would do the research necessary, submit their study to ComEd, ComEd reviews and makes a decision. Then the State of Illinois Power Agency decides to open up blocks and Mr. Terrinoni explained what this means to the committee. The timeline for this would be sometime this summer. Marsha Freeman asked if the project was all contingent upon whether TerrNavigator finds

enough flat land to be able to invest in. Mr. Terrinoni said that was part of it and the other contingency is with enough land how many panels can fit on the land and how this energy is sold. This is part of the study they will need to perform to provide to ComEd. This will then allow them to compete for the block for energy credit. Mr. Terrinoni said this is contingent on many different variables and discussed this with the committee. It is estimated there are twenty usable acres. The lease option is for three (3) years at \$6,800 per year which will start when the lease option is enacted.

TERRANAVIGATOR SOLAR PANELS LANDFILL #2

Mr. Terrinoni said the final lease option is being reviewed by the State's Attorney, the City Attorney and the Mayor. Mr. Terrinoni said the committee could wait a month or could do a generic motion subject to the review of the State's Attorney and Administrator at the board level.

A motion was made by Cathy Ward subject to the approval by the State's Attorney, Mayor, County Board Chairman, City Attorney and the County Administrator proceeds with the lease agreement with TerraNavigator. Motion seconded by Carl Larson. Discussion was held. Sherry Branson asked about the possibility of using land around the interchange ramps and if this would be feasible. Mr. Terrinoni will discuss this with TerraNavigator. Solar panels need to be within a mile of a substation and the committee discussed this. Mr. Terrinoni said the County would enter into the lease as the land owner and then the County and the City would have an intergovernmental agreement separately. That is very possible how this would work and explained this to the committee. Mr. Terrinoni said the lease option is only a part of this there would also be a thirty year lease and explained this to the committee. There would need to be a special use permit. Discussion was held on these steps involved. The City has been involved as a partner in this project. Motion passed (8-0).

INFORMATIONAL ITEMS AND OTHER BUSINESS

WATER PRESERVATION AND PROTECTION ALLIANCE (WPPA)

Sherry Branson discussed the SARA map with the committee. There were suggestions made by the National Resource Conservation. The GIS department is working on these changes that were suggested to improve the SARA map. Once this is done it will be reviewed by committee before moving forward. Ms. Branson read a letter from Senator Duckworth in support of the WPPA in moving forward and possible grants. Their next meeting will be March 23, 2018.

SCOPE OF WORK BEHAVIORAL TASK FORCE RESEARCH REGION 1 EDDNI

Mr. Terrinoni said the Health Department and several other agencies have been meeting for approximately eight (8) months including city police regarding the opioid situation and how to create intervention strategies. The Regional Planning Commission has staff that has been facilitating this. The funding has come from the County's share of what they pay the Commission. The County's allocation has been spent on this project and the Comprehensive Plan. They are requesting an additional \$1,600.00 to complete this work. This was approved at the Finance Committee meeting this month and will move to the full board in March. The County would not turn down financial help from the City if they were interested. Mr. Terrinoni said there are potentially federal grants they can apply for once these studies are completed. He feels it is very important to complete this project in moving forward and discussed this with the committee. Mr. Larson discussed this with the committee. The City will present this request to their next Council meeting. Discussion was held.

INVITATION TO OTHER GOVERNMENTS

Cathy Ward said there had been discussion to invite the library to the next committee meeting. The library has a new director. She offered to invite her to the next meeting. ORDINANCE #397H

AN ORDINANCE AMENDING ARTICLE I OF CHAPTER 43, ETHICS OF THE CITY OF BELVIDERE MUNICIPAL CODE TO ADD A NEW SECTION 29, DRUG FREE WORKPLACE

NOW, THEREFORE BE IT ORDAINED by the Mayor and City Council of the City of Belvidere, Boone County, Illinois, as follows:

- SECTION 1: Article I of Chapter 43, Ethics is amended to add a new section 29, Drug Free Work Place as set forth in the attached Exhibit A which is incorporated herein by this reference.
- SECTION 2: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.
- **SECTION 3**: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.
- **SECTION 4**: This Ordinance shall be in full force and effect from and after its passage and Publication in pamphlet form as required by law, which publication is hereby authorized.

Sec. 43-29 Drug Free Workplace

- (a) The purpose of this Section is to comply with the Illinois Drug Free Workplace Act (30 ILCS 580/1 et seq.). It is the City of Belvidere's policy to maintain a Drug Free workplace. This Section shall apply to all employees of the City of Belvidere. In the event a relevant collective bargaining agreement contradicts the provisions of this Section or is more restrictive than the provisions of this Section, the terms of that collective bargaining agreement shall control with respect to the members of a relevant collective bargaining unit. Further, if a specific employee is a member of a collective bargaining unit, the disciplinary procedures of the relevant collective bargaining agreement shall control.
- (b) Prohibited Conduct.
 - 1) The unlawful manufacture, distribution, sale, dispensation, possession or use of a controlled substance, including cannabis, is prohibited during work hours or while performing City work of any kind, unless specifically authorized by a supervisor as a part of the employees' iob.
 - 2) Being under the influence of any controlled substance while on City priority or while performing City work is prohibited.
 - 3) No alcoholic beverages may be possessed or consumed at any City workplace (including offsite work areas) except in connection with an event authorized by the City or a supervisor.
- (c) An employee shall inform their immediate supervisor of any criminal drug statute conviction for a violation occurring in the workplace no later than five (5) days after such conviction.
- (d) The City of Belvidere maintains an Employee Assistance Program (EAP) which is confidential and may assist an Employee with problems relating to drugs, alcohol or other addictions. Information regarding the EAP is available through the office of the City Clerk.
- (e) Employees who violate this Section may face disciplinary action up to and including termination in conformance with any applicable collective bargaining agreement or the City's Personnel Manual.

FIRST AMENDMENT TO AGREEMENT

between

OSF LIFELINE AMBULANCE, L.L.C., and

CITY OF BELVIDERE

This First Amendment to Agreement ("First Amendment") is made and entered into as of the date last written below, by and between OSF Lifeline Ambulance, L.L.C. ("Contractor"), a provider of emergency medical services and transportation with ambulances, and the City of Belvidere ("City"), a municipal unit of local government duly organized and existing under the laws of the State of Illinois. Contractor and City are hereinafter referred to individually as a "Party" and collectively as the "Parties."

RECITALS:

- A. Contractor and City have entered into an agreement on September 19, 2012 (hereinafter referred to as "**Agreement**"), pursuant to which Contractor has agreed to provide emergency medical services and transportation with ambulances to City in accordance with the terms stated in the Agreement.
- B. Contractor and City now desire to amend the Agreement by extending the term for five years. Accordingly, by this First Amendment the parties intend to set forth in writing all changes and modifications to the Agreement which have been agreed upon by the Parties.

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein contained, and in reliance upon the recitals set forth above and incorporated herein by reference, the parties hereto agree as follows:

- 1. <u>Term and Termination</u>. Section D(1) of the Agreement is hereby deleted in its entirety and replaced with the following language:
 - This Agreement shall be for a term of five years effective as of May 1, 2018 for a term ending April 30, 2023, unless sooner terminated pursuant to Section D(3) hereof. This Agreement may not be extended without the express written consent of the parties.
- 2. **Remaining Terms**. All other terms and provisions as contained within the Agreement are restated herein and incorporated by reference, to the extent not inconsistent herewith.
- 3. **Effective Date**. The parties agree that this First Amendment shall be effective as of May 1, 2018 ("Effective Date").
