### **Canine Warranty:**

- Health guarantee: FM K9 will guarantee canines hips, back, spine and elbows from defect or issue, not related to work or training related injuries for two year's from date of purchase.
- The trainability of the dog is guaranteed for one year from the date of purchase. The warranty will not cover poor training techniques used by purchaser/handler, including abuse or neglect.
- FM K9 offers a one-year satisfaction guarantee of canine from the date of purchase. If not satisfied, FM K9 will replace the canine at no additional cost to the purchaser, which includes the training.

Dram Shop Insurance

Section 10-79 of the City Liquor Code requires all liquor license holders to maintain dram shop liability insurance. It requires \$1,000,000.00 per occurrence and \$2,000,000.00 aggregate dram shop insurance. It also requires a CGL policy in comparable amounts.

Apparently, the City did not always enforce the \$2,000,000.00 aggregate amount. The last two years I have been more involved in renewals and new applications. I found that between 1/3 and 1/2 of entities had \$1,000,000 coverage but lacked the \$2,000,000.00 aggregate required. I spoke with some of the licensees and some of their insurance agents. I learned that the cost of the additional \$1,000,000.00 aggregate coverage ranges between \$250.00 and \$1,000.00 depending on the insurer and type of policy.

I also researched other area municipalities to see what they require for dram shop liability insurance. The only other municipality requiring more than \$1,000,000.00 is Algonquin. Some do not require any more than the state requirement which is \$234,162.91.

Interestingly, the Illinois Liquor Control Act limits the amount of an award relating to the sale of alcohol which results in intoxication. The maximum amount of an award is modified annually in accordance with CPI. The maximum award for 2021 is \$72,671.25 for each person suffering damages and \$88,820.41 for a loss of society or support resulting from death or injury to a person.

**RECOMMENDATION**: Consider decreasing the City's dram shop liability insurance requirement from a \$2,000,000.00 aggregate to a simple \$1,000,000.00 policy more consistent with other municipalities. If the Council wishes to proceed in this direction the motion would be:

Motion to amend section 10-79 of the City of Belvidere Municipal Code to eliminate the requirement of a \$2,000,000.00 aggregate limit for liquor liability insurance.

**COSSAP Officer Cost Share** 

Dear Mr. Drella:

Mr. Catlin and I received your letter reference the COSSAP officer and a request to modify the Intergovernmental Agreement that was signed by both the City of Belvidere and Boone County. We have reviewed the matter with the County Board and in the spirit of cooperation, the County would agree to the following language to paragraph 5A:

"In addition, the parties agree that any overtime costs associated with the Officer's services that are not reimbursed as a grant eligible expense shall be equally divided between the County and the City. The department shall reimburse the City for one-half of the non-grant covered COSSAP Officer's overtime costs on a monthly basis on or about the 15<sup>th</sup> of each month. If there are other costs other than overtime associated with the officer's services that are not reimbursed as a grant eligible expense, the City may request reimbursement from the County on a case by case basis."

In addition, the County would request a modification to 5B, adding the underlined language "The Officer shall not work any overtime assigned as defined in the Collective Bargaining Agreement between the City of Belvidere and FOP Lodge 245 without prior consent of the Chief of Police or his designee and the Public Health Administrator or her designee. Please let me know if this is agreeable. I look forward to hearing from you.
