The Historic Preservation Commission nominated Sonya Dobberfuhl to act as Chairman Pro-Tem.

Sonya Dobberfuhl called the meeting to order at 5:43 pm.

MINUTES: It was moved and seconded (Brooks/Omiotek) to approve the minutes of the April 26, 2022 meeting. Motion carried unanimously.

PUBLIC COMMENT: None.

NEW BUSINESS: Downtown Façade Improvement Grant Program Applications:

Gina DelRose explained the City of Belvidere's façade grant program. Ms. DelRose stated that applications are forwarded to the Commission since the majority of the program area is within the North State Street Historic District and South State Street Historic District along with a few individually landmarked properties. Ms. DelRose stated that the Commission can choose to review all the requests and forward a recommendation to the City Council, review only those within districts or individually landmarked that would need Certificates of Appropriateness, or state that they have no comments for those properties not altering historically significant aspects of the buildings.

David Larson stated that the Commission's scope of review is historic preservation and that the Commission should prioritize projects based on that. David Larson confirmed that the grant is for exterior work and nothing structural or interior.

David Larson stated that 209 South State Street is the old telephone exchange building.

The Commission felt the Belvidere Board of Realtors' request was not historic.

The Commission felt that those that received previous grant money may receive a reduced amount in order to fund new projects.

The Commission felt that painting brick was not appropriate but was willing to assist with tuck pointing and brick repair.

The Commission felt that vinyl windows were not appropriate and would increase funding if wooden windows were to be installed instead.

It was moved and seconded (Larson/Dobberfuhl) to recommend the following grant awards to the Belvidere City Council and to let the remaining balance roll over into next year's grant cycle. Motion carried unanimously.

215 N. State Street- Zero (not appropriate to historic preservation)

209 N. State Street- \$1,725

137 S. State Street- \$2,196

203 Logan Avenue- No recommendation due to lack of façade work

221 Logan Avenue- \$5,000

227 Logan Avenue- \$5,000

104 N. State Street- \$3,000 (will fund tuck pointing and repair but not painting)

527 S. State Street- \$1,696 (would recommend larger amount if changed to wooden windows)
