Chair Lisa Kummerow, Vice-Chair David Kummerow and members Filitsa Platopoulos, Alexandra Omiotek and Becky Tobin were present remotely for the meeting.

**MINUTES:** It was moved and seconded (L. Kummerow/Platopoulos) to approve the minutes from the April 28, 2020 meeting. The motion passed 5-0 by roll call vote.

**2020 Awards Program:** Gina DelRose stated that Phase IV allows for groups of 50 people or less to gather. Typically the awards program has 60-70 people. **US Route 20-** David Kummerow stated that Bryan Farr has been very active on social media and promoting the Historic US Route 20 Association. Mr. Kummerow stated that he is hoping the Association will become more active in Illinois.

**Courthouse Square Area Phase III Survey-** Gina DelRose stated that the Lakota Group was able to complete their surveying work and are still working on the final document.

**Vacant Seat-** Gina DelRose stated that she received two resumes for the vacant commissioner's seat. Ms. DelRose stated that resumes were received from Mindy Long, who regularly attends Commission meetings and is the Local History Librarian at the Ida Public Library and Sonya Dobberfuhr who has past experience working with multiple historic preservation organizations.

Becky Tobin stated that Mindy Long would most likely continue to assist the Commission, therefore, she recommends appointing Sonya Dobberfuhr in order to expand the Commission's knowledge and volunteer base.

The Commission agreed with the sentiment.

It was moved and seconded (L. Kummerow/Tobin) to recommend that the City Council appoints Sonya Dobberfuhr to the Historic Preservation Commission, filling the seat left vacant by Anna Pivoras. The motion passed 5-0 by roll call vote.
