E-911 REPORT - PUBLIC SAFETY BUILDING

911 REPORT

Lt. Perry Gay stated that the 911 NINGA is going very well and moving along swiftly on the project and discussed this with the committee. Seven of the ten Counties have agreements in place. The radio project is continuing to be worked on. Mr. Terrinoni said this is the project that will be in the \$400,000 range and presently waiting for final proposals from Motorola. The hope is the payments would not occur until FY2018. Bard Stark asked what the revenue stream for this project is. Lt. Gay said this will be funded out of the 911 budget. He also said over a period of time this could be a request for funds from City/County to offset 911 costs. The 911 funds come from the surcharge from of the cell phone and land line telephones. Mr. Stark said essentially this will not require funds from the City or the County and completely funded with these surcharge fees. Lt. Gay said that is correct. Mr. Terrinoni said it is incredible how they were able to get the price point down and explained this to the committee. Ms. Ward asked about the financials of the 911 board. Lt. Gay said there will be a down payment of \$108,000 and the rest will be doable while maintaining a balance for other projects. Lt. Gay discussed the mission critical on in house telephone systems with the upgrades costing approximately \$15,000 and went very well with no issues. Lt. Gay continued to explain this. The fire alarm system has been made in the corrections facility and is an ongoing project. The dispatcher hire is in process and will give the department a total of sixteen dispatchers.

FY 2016 FINANCIAL REPORT

Lt. Gay reviewed the financial report stating overtime is a problem and will continue to be a problem. He also stated the \$15,000 phone expense was not a budgeted item as well. Brad Stark asked when the sixteenth dispatcher will be on their own and when the overtime issues will be resolved. Lt. Gay responded saying there will be reductions but was unable to say actually when and discussed this with the committee. Lt. Gay felt this should be reflected in the FY 2017 budget. Discussion was held on the function of the 911 dispatch center on various things. Sheriff Ernest said there was representation sent to Dallas, TX to support the police department and participate in the funerals.

ORDINANCE #307H

AN ORDINANCE AUTHORIZING THE SALE OF CERTAIN
PERSONAL PROPERTY (POLICE VEHICLES (SEIZED) / TRAILER AND
PUBLIC WORKS TRUCK)

WHEREAS, a Court of competent jurisdiction forfeited an interest in certain motor vehicles which are described in Exhibit A (the Vehicle) and vested title in said vehicle to the City of Belvidere; and

WHEREAS, the City of Belvidere Police Department also is in possession of one 2006 Thor Dutchmen Trailer also described in Exhibit A; and

WHEREAS, the City of Belvidere Public Works Department is in possession of one 1982 Chevy C2500 and one 1991 Volvo WG42 5 yd. dump truck, as identified in Exhibit A which are no longer needed or useful;

Whereas, the Vehicles constitute surplus personal property within the meaning of $65\ \text{ILCS}\ 5/11-76-4$; and

WHEREAS, the Corporate Authorities of the City find that the previously referenced Vehicles and Trailer are no longer necessary or useful to or in the best interest of the City.

NOW THEREFORE IT IS THERFORE ORDAINED by the MAYOR and CITY COUNCIL of the City of Belvidere, Boone County Illinois, as follows:

- **SECTION 1:** The foregoing recitals are incorporated herein as if fully set forth.
- <u>SECTION 2</u>: The Mayor, or his designee, is authorized and directed to sell the Vehicles identified in Exhibit A by any means authorized by State Statute, including but not limited to an internet auction site. Further, the Mayor or his designee may elect to separate the box portion of the 1982 C2500 and sell that separately.
- SECTION 3: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.
- **SECTION 4:** All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

Belvidere Police Join Forces with Agencies Statewide for 2016 Illinois Speed Awareness Day Campaign

Belvidere, IL - During Illinois Speed Awareness Day this July 27th, the Belvidere Police Department is taking a proactive approach to promote safety for motorists, pedestrians, and cyclists through both education and enforcement. Officers are going to be conducting both roving and stationary patrol in residential areas as well areas known for traffic crashes. In Illinois during 2014, speed was the reason for 32.4% of all traffic fatalities. That's 348 deaths for the year, or one life every 25 hours. These lives can be easily saved by being aware of our speed and understanding how speeding impacts a crash.

In residential areas, speeding can have the following consequences:

- When a pedestrian is hit by a car at 20 MPH there is a 10% likelihood of being killed, at a speed of 30 MPH the percentage increases to a 50% likelihood of being killed.
- Approximately 16% of the speed-related fatalities in Illinois were comprised of pedestrians and cyclists.
- The higher the speed at impact, the more severe the injuries sustained.
- 37.4% of the speed-related crashes result in injuries.
- When speeding there is a greater chance that other road users will misjudge how fast you are traveling.
- Speeding extends the distance required to stop a vehicle in emergency situations.
- 87% of the speed-related fatalities occur on local roadways.
- Speeding reduces a driver's ability to navigate safely around curves or objects in the roadway.

Let's all do our part by taking a proactive approach to prevent fatalities and reduce injuries on the roadways by being aware of our speed and obeying the speed limit signs ALL the time.
