The City's IEPA supplemental permit for land application of sludge on snow covered ground has expired and needs to be renewed. Attached to this memo is a proposal from Baxter & Woodman to complete the permit application and provide the required documentation in an amount not-to-exceed \$4,500.00.

I would recommend approval of the engineering services work order from Baxter & Woodman, in an amount not-to-exceed \$4,500.00, to complete the supplemental permit for winter sludge application. This work will be paid for from Line Item #61-5-820-6190.

Project Description: The City does not have adequate sludge storage during the winter months, therefore the City's current Land Application of Sewage Sludge needs to be amended to include a provision to allow land application during the winter on snow and ice covered ground. We will provide assistance to prepare the permit application forms and submit to IEPA as soon as possible. The scope of services is outlined in Attachment A.

SCOPE OF SERVICES

Obtain the following City records to assist with the preparation of the IEPA sludge land permit renewal application:

- 1. Annual sludge production between November February.
- 2. Sludge User Information forms, location map and soils map for each farm where sludge will be land applied during the winter months.
- 3. Methods for land applying and incorporating the sludge into the ground during when the ground is frozen or ice covered.

Upon receipt of this information:

- 1. Review and compare sludge user information for each owner where sludge is land applied and confirm plat maps are available for all fields.
- 2. Complete the IEPA permit application forms for sludge land application. Submit to City for review. Incorporate the City's comments (if any).
- 3. Prepare a cover letter and submit permit application to IEPA.
- 4. Subsequent to IEPA review of the permit renewal forms, we will follow-up on comments or additional requirements that IEPA may make or request.

Habitat for Humanity of Boone County has been offered the above property as a gift. We have evaluated the property and obtained a proposal for the demolition and off-site disposal of the single-family residence on the parcel. In its place, Habitat would like to build a single-family home and needs to complete its due diligence to determine if the costs are feasible (in keeping with the mission of serving families falling within low-income guidelines).

We are requesting that the City waive the fees for a demolition permit and, to the extent applicable later, all building, water and sewer connection, and other fees. We understand that Habitat will be responsible for expenses directly incurred by the city (such as cost of materials) even if fee and service cost waivers are approved. This request is in keeping with the City's past practice to facilitate the work for low-income families and enable Habitat to complete the project promptly, within budget. Reference past projects at 407 West Madison Street, 1021 West Fifth Street, and others.

We understand the request for waiver will need to be scheduled for consideration by the City Council. Please keep us informed concerning scheduled dates on which our appearance and input may be beneficial.
