ORDINANCE #472H

AN ORDINANCE AUTHORIZING THE SALE OF CERTAIN PERSONAL PROPERTY (POLICE DEPARTMENT VEHICLES AND SEIZED VEHICLES) AND APPROVING THE PURCHASE OF NEW VEHICLES

WHEREAS, the City of Belvidere Police Department is in possession of certain used vehicles, described in Exhibit A that are no longer needed or useful; and

WHEREAS, a Court of competent jurisdiction forfeited an interest in certain motor vehicles which are also described in Exhibit A and vested title in said vehicle to the City of Belvidere; and

WHEREAS, the Vehicles constitutes surplus personal property within the meaning of 65 ILCS 5/11-76-4; and

WHEREAS, the Corporate Authorities of the City find that the previously referenced Vehicles are no longer necessary or useful to or in the best interest of the City.

NOW THEREFORE IT IS THERFORE ORDAINED by the MAYOR and CITY COUNCIL of the City of Belvidere, Boone County Illinois, as follows:

SECTION 1: The foregoing recitals are incorporated herein as if fully set forth.

SECTION 2: The Mayor, or his designee, is authorized and directed to sell the Vehicles identified in Exhibit A by any means authorized by State Statute, including but not limited to an internet auction site or trade in for new vehicles.

SECTION 3: The Mayor, or his designee is authorized to purchase a new 2019 Ford Fusion and 2019 Ford Edge from Manley Motors of Belvidere with the trade in of the Vehicles identified in Exhibit A.

SECTION 4: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 5: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 6: This Ordinance shall be in full force and effect from and after its passage and publication in pamphlet form as required by law which publication is hereby authorized.

RESOLUTION #2102-2019 A RESOLUTION DETERMINING A VACANCY IN THE OFFICE OF ALDERMAN FOR THE 2nd WARD ALDERMAN SEAT EXPIRING APRIL 30, 2021

WHEREAS, Alderman Michael Borowicz was duly elected and sworn in as an alderman for the 2nd Ward in the City of Belvidere on May 1, 2017; and

WHEREAS, Alderman Michael Borowicz has repeatedly failed or refused to attend meetings of the City Council or the Committee of the Whole or to attend to any of the duties of the 2nd Ward Alderman; and

WHEREAS, the City of Belvidere City Council meets no less than 24 times per year and the Committee of the Whole meets no less than 24 times per year; and

WHEREAS, During Fiscal Year 2019 (5/1/2018 - 4/30/2019) Alderman Michael Borowicz only attended 21 meetings while missing 27 meetings frequently missing multiple meetings in sequence and entire months at a time; and

WHEREAS, commencing April 8, 2019, through the date of this Resolution, Alderman Michael Borowicz only attended one meeting (June 24, 2019), which he left early, and otherwise failed to attend to the duties of Alderman for Ward 2; and

WHEREAS, the City has attempted to contact Alderman Michael Borowicz to determine the reasons for his absences to no avail; and

WHEREAS, Alderman Michael Borowicz has failed to provide the Council, the Clerk or the Mayor any legitimate reason for his absences or any evidence of his intent to fulfill the duties of Ward 2 Alderman; and

WHEREAS, the City Council finds that it is incumbent upon a seated alderman to attend to the duties of alderman by attending City Council and Committee of the Whole meetings to represent the citizens of the respective wards through his or her vote; and

WHEREAS, the City Council finds that where an alderman repeatedly and consistently fails to attend to the duties of his or her office by not attending meetings of the City Council and Committee of the Whole the alderman abandons the office of alderman.

NOW, IT IS THEREFORE RESOLVED, by the Mayor and City Council of the City of Belvidere, Illinois as follows:

- 1) The foregoing recitals are hereby incorporated by this reference.
- The City Council finds that Alderman Michael Borowicz has failed to attend City Council or Committee of the Whole meetings since April 8, 2019 (with the exception of June 24, 2019).
- 3) The City Council further finds that Alderman Michael Borowicz ineffectively represented his ward during fiscal year 2019 as he only

attended 21 meetings, while failing to attend 27 meetings, frequently missing multiple meetings in a row and entire months at a time.

- 4) The City Council hereby determines that a vacancy exists in the office of Ward 2 Alderman for the term expiring April 30, 2021 because Alderman Michael Borowicz has abandoned his office within the meaning of 65 ILCS 5/3.1-10-50(c) by reason of his failure or refusal to attend meetings of the City Council and the Committee of the Whole without valid reason or evidence that Alderman Michael Borowicz intends to fulfill the duties of Ward 2 Alderman.
- 5) In accordance with 65 ILCS 5/3.1-10-50(c), a vacancy exists in the office of Ward 2 Alderman for the term expiring April 30, 2021 immediately upon passage of this resolution, which office will be filled in accordance with State Statute.
