Gay discussed the purchase of some laptops. The State has been providing funding. He talked about upcoming expenditures. The 16^{th} dispatcher is doing well. There was discussion held on the new hire of Chief Hulett for District 2. Chief Worley was appointed to the 911 Board. There is no representative on the 911 Board for the rural ambulance position.

FY 2017 FINANCIAL REPORT

Lt. Gay said there are some outstanding invoices thinking the Maintenance of Equipment, which is most of the technology, will come in under budget to be able to assist with the overtime budget.

FY 2018 BUDGET

Mr. Terrinoni said the committee reviewed the FY 2018 budget last month with no recommended amendments. The Finance Committee has reviewed almost all budgets for the County and has not recommended any amendments at this time. This maintains a sixteen (16) count of dispatchers and two (2) IT personnel. The Motorola Console purchased will need to be paid and has been budgeted for in FY 2018. Discussion was held on the amount of phone/internet providers that are paid.

Grant Anderson said his department has been extremely busy and hopes to get a new aerial which is the largest line item in the budget. Jeffrey Carlisle asked if these would be used for revenue. Mr. Anderson replied saying he plans to have future conversations with WINGIS to discuss revenue for the department.
