Chair Lisa Kummerow, Vice-Chair David Kummerow and members Filitsa Platopoulos and Becky Tobin were present remotely for the meeting.

MINUTES: It was moved and seconded (Platopoulos/D. Kummerow) to approve the minutes from the February 25, 2020 meeting. The motion carried unanimously.

PUBLIC COMMENT: Mindy Long (via e-mail) stated that the Ida Public Library is looking for virtual tours of historic homes, public buildings and favorite Belvidere locations to share as part of their virtual programming.

Gina DelRose stated that people could also interview other people that have unique experiences to share.

Work Plan

2020 Awards Program: Gina DelRose advised the Commission to wait until the May meeting to determine a new date for the Awards Program.

Gina DelRose informed the Commission of two façade renovations downtown. One is at the State Street Commons building in which the stucco was replaced and the other is at the former Masonic Temple in which siding was removed to reveal the original windows and columns.

Promotional/Fundraising Events: Gina DelRose stated that, due to the current pandemic, a fundraising event will not be held until at least the fall.

Maintenance Small Grant: Gina DelRose provided a recap for the grant application submitted for 405 W. Hurlbut Avenue.

Becky Tobin stated that the applicant has lived at the property for at least 50 years and has been active in historic preservation in the past.

It was moved and seconded (L. Kummerow/D. Kummerow) to approve up to \$1,500 but not exceeding the 50% match for the exterior painting at and siding replacement at 405 W. Hurlbut Avenue. The motion carried unanimously.

David Kummerow provided a recap for the grant application submitted for 127 W. Locust Street.

It was moved and seconded (Tobin/Omiotek) to approve \$2,500 for the exterior window repair at 127 W. Locust Street. The motion carried 3-0-2. L. Kummerow and D. Kummerow abstained.

10 Year Plan: No updates.

Expenditures: Gina DelRose stated that the Commission made a profit of \$764. Ms. DelRose noted the spreadsheet that included revenues and expenses with a breakdown of what accounts the expenses were paid out of it.
