1. COMPLETE ALL WORK TO BE DONE UNDER THIS PERMIT IN ACCORDANCE WITH THE SPECIFICATIONS OF THE CITY OF BELVIDERE PUBLIC WORKS DEPARTMENT AND THE "STANDARD SPECIFICATIONS FOR ROAD AND BRIDGE CONSTRUCTION", LATEST REVISED EDITION, OF THE STATE OF ILLINOIS.
2. TRAFFIC CONTROL SHALL BE IN ACCORDANCE WITH THE "MANUAL ON UNIFORM TRAFFIC CONTROL DEVICES" AND SHALL BE MAINTAINED 24 HOURS A DAY UNTIL THE PATCHING WORK IS COMPLETED AND ACCEPTED BY THE CITY.
3. TEMPORARY ASPHALT PATCHING IS REQUIRED IN ALL VEHICLE AND PEDESTRIAN TRAFFIC AREAS AND MUST BE INSTALLED PRIOR TO OPENING THE AREA TO TRAFFIC. TEMPORARY PAVEMENT PATCH SHALL CONSIST OF A TWO INCH THICK MAT OF COLD MIX ASPHALT (MC 250) PLACED ON THE AGGREGATE BASE COURSE AND MUST BE MAINTAINED UNTIL THE PERMANENT PATCH IS COMPLETED AND ACCEPTED BY THE CITY.
4. COMPLY WITH ALL ORDINANCES, INCLUDING, BUT NOT LIMITED TO INDEMNIFY, DEFEND AND HOLD THE CITY, IT'S OFFICERS, EMPLOYEES AND OFFICIALS HARMLESS FROM ANY CLAIM OR ACTION AND TO PROVIDE INSURANCE TO COVER THE CITY FROM ANY CLAIM AS REQUIRED
