MINUTES: It was moved and seconded (Dobberfuhl/Colla) to approve the minutes from the July 27, 2021 meeting. The motion carried with a 5-0 voice vote.

PUBLIC COMMENT: Kris Bryan questioned if the Commission was aware of the current condition of the Baltic Mill. Mr. Bryan stated that he is concerned about the neglect of the building.

David Kummerow stated that the Belvidere Township Park District is looking into the matter.

Gina DelRose stated that she recommended to previous park district staff that they should explore the possibility of landmarking the Baltic Mill in order to receive financial assistance for maintenance and repairs.

David Kummerow requested clarification for the Certificate of Appropriateness for fascia repair at 628 Buchanan Street that the Commission approved on June 24, 2021 with a 4-0 roll call vote.

Alex Colla showed pictures and provided an update of the renovations at 628 Buchanan Street.

David Kummerow acknowledged Kris Bryan and thanked him for coming.

Kris Bryan stated that he is feeling better and is interested in rejoining the Commission.

Gina DelRose stated that it is very important that Commission members regularly attend the meetings due to the need for quorums and said she anticipated needing assistance with events hosted by the Commission.
