With a guorum present, Chair David Kummerow called the meeting to order at 5:37 pm.

MINUTES: It was moved and seconded (L. Kummerow/Platopoulos) to approve the minutes from the January 25, 2018 meeting. The motion carried unanimously.

NEW BUSINESS: None

UNFINISHED BUSINESS:

Work Plan

<u>2018 Awards Program</u>: Gina DelRose stated that there was a list of nominations in the packet. Ms. DelRose stated that it does not appear that some of the nominated projects will be done in time for the 2018 awards. Ms. DelRose stated that there were two houses that repainted the architectural details and improved their landscaping. However, during the renovations, both houses resided with vinyl siding instead of painting the wood siding.

Filitsa Platopoulos stated that she does not want to set a precedent by awarding vinyl siding. The Commission is awarding historic preservation efforts which would be repainting and repairing the original wood siding, not replacing with vinyl siding.

The Commission agreed.

Anna Pivoras stated that the awards program could highlight the maintenance grant winners.

David Kummerow stated that before and after pictures could be displayed.

Promotional /Fund Raising Events:

Mystery Dinner- Gina DelRose stated that there was a breakdown of the budget in the packet. Ms. DelRose stated that enough funds were raised to provide two landmark maintenance grants.

Gina DelRose stated that she has received many positive comments about the event and people asking about next year's theme.

Anna Pivoras stated that Drew Pivoras is working on next year's theme.

Stained Glass Window Tour:- Gina DelRose stated that there was a list of churches with comments about their history and windows in the packet. Out of the 17 local churches, 5 have large stained glass windows and 1 has a presentation about its history in their lobby.

Anna Pivoras stated that the Boone County Museum of History has a stained glass window on display and would be happy to host the program's lunch.

Gina DelRose questioned what the price should be. Ms. DelRose suggested \$25.00 since lunch would be included.

David Kummerow stated that the window tour should be held in early June.

Anna Pivoras stated that Gary Blatchford could host a stained glass window presentation at the museum.

Leath Warehouse Update: No updates.

<u>Maintenance Small Grant:</u> Gina DelRose stated that one application has been received. The deadline for applications is March 31st. Ms. DelRose stated she would provide the Commission all applications to be voted at the next meeting.

<u>10 Year Plan:</u> Gina DelRose stated that the plan was submitted to the State of Illinois and reimbursement was requested. Ms. DelRose stated that since the plan was completed after the grant's deadline, the state has not approved the full reimbursement. Ms. DelRose stated that she has been in contact with the state to address the matter.

Expenditures: The only expenditures were for the mystery dinner.

<u>Friends of Preservation:</u> David Kummerow stated that the awards program in May would be an appropriate time to ask attendees how the Commission could alter the Friends of Preservation meetings to improve the attendance.
