MINUTES OF A SPECIAL MEETING OF THE BOARD OF FIRE & POLICE COMMISSIONERS AS HELD ON JULY 19, 2023 AT 6:00 P.M. IN THE BELVIDERE CITY HALL

CALL TO ORDER: 6:00 PM.

ROLL CALL: Commissioners John Hunter, Michael Phillips & Carlos Villareal appeared in person in the Meeting room. No Commissioner appeared through electronic means. Also present was the Police Chief, Deputy Police Chiefs Wallace and Smaha, and Police Detective Sergeant Michael Ball. The Fire Chief and Fire Captain LeTourneau were also present. There were no members of the public present.

APPROVING OF THE MINUTES: None presented

COMMUNICATIONS:

A. Bills Payable.

(1) The Board reviewed an Invoice from Personnel Evaluation, Inc. in the amount of \$175.00 (includes \$75.00 for services provided to the Fire Department) for the administration of PEP Tests to four Firefighter Candidates, et al. Commissioner Phillips made a Motion To Pay The Invoice As Presented. Commissioner Villareal verbally seconded that Motion. A Roll Call Vote was held with the following results:

 - (2) Probationary Police Officer Bendel is in Week 11 at the Police Training Institute ("PTI") in Champaign, but he was injured and the Police Chief is now awaiting a Progress Report from PTI; and
 - (3) Probationary Police Officer Hernandez in currently in Step II of the Field Training Officer ("FTO") Program.
- C. Fire Chief's Report. The Fire Chief stated that he would not make a verbal Fire Chief Report and would rely on the Fire Department's Agenda Items for tonight's Board Meeting.

UNFINISHED BUSINESS: None.

NEW BUSINESS:

A. Fire – Approval of Updated Board Rules and Regulations.

The Fire Chief then discussed with the Board the proposed changes to Chapter 5 of the Board's Rules and Regulations and there are no other proposed amendments other than to Chapter 5. The Board took no action on this topic.

(B) Fire – Approval of Polygraph Review for Candidates Who Passed the Mandatory Background Investigation.

The Fire Chief stated that the Board had recently ruled that Firefighter Candidates Sean Rushing and Tyler Schlaf had passed the required Background Investigation and the Fire Chief further requested that the Board authorize each of these Firefighter Candidates to take the required Polygraph Examination. Commissioner Phillips made a Motion To Request that Firefighter Candidates Sean Rushing and Tyler Schlaf submit to the required Polygraph Examination as required by the Board's current Rules and Regulations. Commissioner Hunter verbally seconded that Motion. A Roll Call Vote was held with the following results:

(C) Fire – Approval of Quote from Resource Management Associates to conduct Promotional Written Examination and Testing.

The Board next examined a written quote from Resource Management Associates ("RMA") to conduct the Fire Department Promotional Testing for the Board. Commissioner Phillips made a Motion To Accept the Quote from RMA for Promotional Testing Contingent Upon the Approval of the Board's Attorney as to the contents of the written Agreement for such services. Commissioner Villareal verbally seconded that Motion. A Roll Call Vote was held with the following results:

The Police Chief requested that the Board refer these proposed rule changes to City Attorney Michael Drella for his review and comment. Commissioner Phillips verbally made a Motion To Approve In Concept the proposed changes to the Police Department's portion of the

Board's Rules and Regulation and to refer said changes to Belvidere City Attorney Michael Drella for his review and comment. Commissioner Hunter verbally seconded that Motion. A Roll Call Vote was held with the following results:

(G) Police – Authorize Sending Candidates for Polygraph Examinations.

The Police Chief stated that the Board had ruled at tonight's Board meeting (See Agenda Item F) that Entry Level Police Officer Candidates Jesus Lara-Para and Ashley Hauser had passed the required Background Investigation and the Police Chief further requested that the Board authorize each of these Police Officer Entry Level Candidates to take the required Polygraph Examination. Commissioner Hunter made a Motion To Request that Police Officer Entry Level Candidates Jesus Lara-Para and Ashley Hauser submit to the required Polygraph Examination as required by the Board's current Rules and Regulations. Commissioner Villareal verbally seconded that Motion. A Roll Call Vote was held with the following results:
