A. Police – Review of Lateral Applicant Background.

The Board then considered the written Background Investigation Report of Lateral Police Officer Applicant, Matthew Gibson, currently a Northern Illinois University Police Officer. Commissioner Hunter made a verbal Motion To Find that Lateral Police Officer Applicant, Matthew Gibson, had successfully completed the required Board Interview step in the Hiring Process. B. Police – Personality Assessment Testing MPulse or PEP.

The Board then discussed with the Police Chief whether the Board should continue utilizing the MPulse Assessment System for the screening of Police Officer applicants which the Board only recently approved for use. The Police Chief questioned the results so far from the use of the MPulse system as more of a psychological test rather than a personality assessment test. The Police Chief suggested that the Board revert to the use of the PEP Test for the personality assessment or screening purposes. Commissioner Phillips made a verbal Motion To Authorize the Police Department to resume using the PEP Test instead of the MPulse Test. Commissioner Hunter verbally seconded that Motion. A Roll Call Vote was held with the following results:

The Fire Chief noted that both of the current Fire Lieutenant and Fire Captain Promotional Lists will be expiring on March 31, 2024. Commissioner Phillips made a verbal Motion To Authorize the Fire Chief to sign the proposed agreement with RMA contingent upon the prior written approval of the proposed agreement from the Board's attorney, Roberta Holzwarth. Commissioner Villareal verbally seconded that Motion. A Roll Call Vote was held with the following results:
