2024-04: Sister Cities Association of Belvidere, Inc (SU): Application of Sister Cities Association of Belvidere, IL Inc., PO Box 1822, Belvidere, IL 61008 on behalf of the property owner, Gail Spoden, 315 South State Street, Belvidere, IL 61008 for a special use to install a mural at 315 South State Street within the CB, Central Business District (Belvidere Zoning Ordinance Sections 150.1012(A)(1) and 150.904 Special Use Review and Approval Procedures). The proposed mural will be mounted on the north side of the building depicting Belvidere's tri-city relation with the two sister cities. PIN: 05-25-353-010.

## PUBLIC HEARING FOR CASE 2024-04 OPENED: 6:03 PM

Ms. Gina DelRose was sworn in. Ms. DelRose stated the case was published in the Boone County Journal on February 22, 2024 and notifications were sent by certified mail to property owners within 250 feet of the subject property on February 20, 2024. Ms. DelRose summarized the staff report dated March 6, 2024 and stated the recommendation is for approval of case #2024-04 for special use to install a mural at 315 South State Street, Belvidere IL within the CB, Central Business District subject to 2 conditions.

Commission raised concern regarding the condition of the current appearance of the wall, placement of the mural, size of the mural, weight of the panels.

Ms. Gina DelRose explained the appearance of the wall is the responsibility of the property owner. The placement of the mural is chosen by the applicant. The size of the mural helps with the initial cost of the mural, restoration and removal for maintenance of the building. The weight of the mural has not been a factor in other murals in the city.

Mr. Brad Peters was sworn in at 6:14 pm. Mr. Peters gave a presentation and answered commission members questions. He explained the mural would cover a portion of the wall and will be securely anchored. The location was picked to prevent graffiti on the mural. There will be visitors from France here for the unveiling of the mural.

No further questions from commission.
