A. Police—Approve Memorandum of Agreement (MOA) with Braden Counseling Center. Commissioner Hunter made a verbal Motion to Approve as Presented the MOA. Commission Villareal verbally seconded this Motion. A Roll Call vote was held with the following results:

B. Fire —Approve Final Eligibility Roster. Fire Chief Schadle provided the Commissioners with the list and discussed the grading process for ranking each candidate. A Roll Call vote was held with the following results:

C. Fire—Approve Candidate Background. Fire Chief Schadle provided the candidate background on Camden Johnson and after a thorough review and explanation Commissioner Villareal made a verbal Motion to Accept as Presented the Candidate Background Report on Camden Johnson. Commissioner Rathburn verbally seconded this Motion. A Roll Call vote was held with the following results:

Chair Hunter declared the Motion as Passed and the Background Report as accepted.

D. Fire—Review Candidate Polygraph. Fire Chief Schadle presented the polygraph report on Candidate Camden Johnson which appeared to show inconsistencies with questions on his application and background forms. Chief Schadle explained that he contacted Cops and Fire, the facilitators of the polygraph examination, to address these inconsistencies. It was explained by the polygrapher that he had opted for a different style of polygraph because the candidate had taken the test administered to all other candidates as part of a previous job application.

Chief Schadle reinterviewed the Candidate and all his references and determined, after an explanation of the process of the test administration, that the results of the test were inconsistent with the Candidate's character and that the test administration was not consistent with the requirements for the testing of other applicants.

E. Fire—Approve Candidate Polygraph. Commissioner Rathburn mad a motion to Approve Candidate Johnson's Polygraph test despite the recommendation of the polygrapher. Commissioner Villareal verbally seconded this Motion. A Roll Call vote was held with the following results:

Chair Hunter declared the Motion as Passed and the polygraph approved.

F. Fire—Candidate Oral Interview. An interview was conducted by the Commission and Fire Chief Schadle and based on that interview Commissioner Hunter made a verbal Motion to declare Candidate Johnson passed his oral interview. Commissioner Rathburn verbally seconded this Motion. A Roll Call vote was held with the following results:
